National Legislative News**No Child Left Behind / SKILLS Act**

Please continue to contact your Representatives and Senators to ensure the inclusion of the SKILLS Act in the reauthorization of NCLB.

The SKILLS Act would place a state-certified school library media specialist in every school.

There is a possibility that the NCLB rewrite will be postponed until the next session of Congress.

SKILLS - Strengthening Kids' Interest in Learning and Libraries Act

This bill is in the first step in the legislative process. Introduced bills go first to committees that deliberate, investigate, and revise them before they go to general debate. The majority of bills never make it out of committee.

Sep 11, 2007: Referred to the Subcommittee on Early Childhood, Elementary, and Secondary Education.

This bill is identical to [S. 1699](#) (Status: Introduced).

Committee Assignments

This bill is in the first stage of the legislative process where the bill is considered in committee and may undergo significant changes in markup sessions. The bill has been referred to the following committees:

LSTA –Library Services and Technology Act

The last information I could find on this bill H.R. 3043 stated that each house passed its version of the bill that provides funding for these monies. ALA supports the Senate version.

At Hillcrest Elementary School in Belton, second graders were very busy throughout first quarter. Classes learned about the rules of the library, talked about safe places to keep their books, and started checking out. During their first 2 visits, the children heard the book Animals Should Definitely Not Wear Clothing, and then we wrote our own class book (Animals Should Definitely Not Check Out Library Books) in which the kids thought of an animal that should not check out a library book.

Later, as the students learned about American symbols in class, they heard the story Saving the Liberty Bell in the library. The children then went into the computer lab where we helped them complete a Liberty Bell research page, which the kids then took back to class & wrote sentences from their "notes." The teachers were amazed that their second graders were able to do research! J

To build on learning how to research and take notes, the children moved on to Johnny Appleseed. The kids were shown how to print a page from a website, and then in the library, we learned how to identify & highlight

important words. From that, the kids were then able to write 2 sentences of fact and 2 sentences of tales people told about Johnny Appleseed. One class even typed their sentences & we posted them on our webpage!

Belton High School Freshman Center LMC just concluded its fall Library Card campaign. Four Academic Focus classes had 100% participation and enjoyed donut parties with donuts from local bakery, Duke's Baker's Dozen. Students filled out Library Card applications at school, and Teri Milbourn and her staff at Cass County Northern Resource

Center in Belton made cards for all the students. They also made it very convenient for students and their families to have their fines forgiven in November by contributing canned good for Harvesters. . Students saw a PowerPoint presentation during Academic Focus explaining how to access remote reference data bases and how to have their public library fines forgiven in November.

LEE'S SUMMIT NEWS BY KAREN MCKARNIN

Our newest elementary school, Summit Pointe Elementary, opened this fall. We welcome new media specialists, Kim Bell at Summit Pointe and Michael Russell at Lee's Summit High School, to our team.

Author Roland Smith visited Lee's Summit's 17 elementary and 3 middle school libraries this fall. During his 3-week visit, he mesmerized the students with tales of his adventures and writing tips.

Thirteen Lee's Summit media specialists accompanied Sharon Early, Library/Media Services Director, to the AASL conference in Reno, Nevada in October. Sandy Stuart-Bayer, Lee's Summit High School media specialist, presented a workshop on the new Web 2.0 technologies.

Lee's Summit elementary libraries hosted fall book fairs to benefit the Lee's Summit Reading Council, a chapter of the International Reading Association. Greenwood Elementary media specialist Sharon O'Donnell is president of the LSRC, which is one of the largest chapters in Missouri. The LSRC provides funds to support local literacy activities, such as the recent visit of Missouri author Judy Young. They also sponsor the Young Authors Conference, field trips to the Children's Literature Festival in Warrensburg, scholarships and books for underprivileged children.

Dr. David Loertscher, nationally-recognized expert on school libraries and information literacy and former AASL president, presented to district elementary principals and library media specialists on November 15. Dr. Loertscher's presentation provided an opportunity for principals and media specialists to explore ways to enhance flexible scheduling and collaboration between teachers and media specialists, which is a district CSIP goal. A group of library media specialists are currently conducting a book study of his book, *Ban Those Bird Units! 15 Models for Teaching and Learning in Information-rich and Technology-rich Environments*, which emphasizes collaboration and higher-level thinking.

K C M O NEWS BY JANE PETTMAN

This school year is an MSIP (Missouri School Improvement Plan) Accreditation year for the Kansas City MO School District, which means all of the district's librarians under the direction of their District Library Coordinator, Grace Bridgeford, are gearing up for the MSIP visits in the spring.

Maria-Elena Singelman, librarian at Northeast Middle School, is continuing her work as an advocate for better Spanish resources for the district's Latino student population. She recently attended the Feria Internacional

de Libros (FIL, International Book Fair) that took place in Guadalajara, Mexico from November 24-December 1st. There she met librarians, both public and school, translators, editors, and book representatives from different countries: Germany, Spain, Cuba, and Colombia, to name a few and from the US: Philadelphia, New York, California, New Mexico, and Miami. Maria-Elena has always advocated for the selection of Spanish books that are not mere translated versions of American literature. At the FIL, Maria-Elena most like got her fill for original Spanish works f

for children and young adults and she brought back her recommended lists for district librarians to choose from.

In Maria-Elena's words: "My main accomplishment, other than enjoying the people and the atmosphere, was learning about publishers who have beautiful children's literature that just begs to be enjoyed. I met several authors and many publisher representatives who were equally enthusiastic in recounting a particular children's book...It was a great educational, productive, and professional experience."

By the way, Maria-Elena is also looking for opportunities to talk with other library groups that might be interested in purchasing great literature in Spanish.

In collaboration with the KC Public Library's National Children's Book Week activities, the Upper Elementary students of Faxon Montessori School went on a field trip with their school librarian, Jane Pettman. They visited the Bluford Public Library to attend a presentation by Shane Evans, a local artist and children's book illustrator. Some of Mr. Evans's works include, "No More: Stories and Songs of Slave Resistance", "Take it to the Hoop, Magic Johnson", "Fishing Day", "Osceola: Memories of a Sharecropper's Daughter", "Down the Winding Road". Many of Faxon's students love to draw and check out drawing books from the Library regularly. It was good for them to see and listen to a real artist.
